4. Details of our assessment

SIMEC Uskmouth Power Ltd. have provided NRW with all necessary reports in accordance with the requirements of the permit in respect of the calendar year 2021.

As the installation has continued in a state of non-operation throughout the year such

reports have included 'nil returns'. This is accepted by NRW. For as long as this situation continues 'nil returns' must continue to be submitted and in accordance with the normal reporting deadlines. Where there are no values to report this must be noted in the reporting box rather than it being left blank. This avoids any misinterpretation that the Operator has provided, and NRW accepted, an incomplete report.

Permit Condition 4.2.5 relates to waste returns which have a de minimus for reporting against. NRW has not received any such reports during 2020.

The Uskmouth Power Station Annual Environmental Report 2021 includes 'Figure 1 Updated Permitted Installation Boundary August 2021'. It is noted that this boundary differs slightly from that in the existing permit, in particular that part of the installation that joins with the jetty area. Whilst this may not be of significance to the operations on site it should be noted that it is the installation boundary that is in Schedule 7 of the current permit that remains the legal boundary until any change is effected by means of a determined variation.

NRW remains aware that there is a large quantity of pfa/fgd residue material that remains on site from when the installation was operational as a coal fired station. This has now been stored for a considerable period. NRW has been informed that there are plans for this material but we still await written confirmation of the final plans. **Action (1): SIMEC Uskmouth Power to provide written confirmation of plans for the pfa/fgd residues as soon as possible.**

The quantity of such material that remains at the installation also needs to be confirmed. **Action (2): SIMEC Uskmouth Power Ltd. to provide the estimated quantity of pfa/fgd residues that remain.**
