4. Details of our assessment

This was the first physical Site Familiarisation by Berwyn Williams. Met with Steve Swygart QHSE Manager and colleagues.

Had a physical tour of the factory and it's operations and how the permitted activity is incorporated into the operation.

Main activity is the Melting, including making alloys, of non-ferrous metals, including recovered products (such as refining or foundry casting) where - (i) the plant has a melting capacity of more than 4 tonnes per day for lead or cadmium or 20 tonnes per day for all other metals; and (ii) any furnace (other than a vacuum furnace), bath or other holding vessel used in the plant for the melting has a design holding capacity of 5 or more tonnes. The other material used is "PF4", a bitumen and white spirit mix, with which the cables are coated to prevent "cold welding", i.e. fusion of cable during its storage. The white spirit evaporates, leaving the cable coated with bitumen. Fumes from the lead melting pots are extracted and released abated from the process and discharged into the local atmosphere outside the process building (release point A2).

Emission parameters are -
Particulates - 1mg/m³ ELV
Lead - 0.1 mg/m³ ELV
VOCs - 20mg/m³ ELV

The process is not operated on a continuous basis, but is run on demand, as it caters for a specialist market. Lead alloy ingots are delivered in bulk then melted within a vessel.

There are no direct releases from the installation into controlled waters. Used cooling water passes through the site drains to a settlement lagoon, based in behind the main reception building. Solids are removed periodically by tanker and clear water drained into the River Clywedog.

Emission parameters are -
Lead - 1mg/l ELV
COD - 125 mg/l ELV

The majority of wastes from the process are sent for recovery, with rags and empty PF4 drums currently treated as part of hazardous waste disposal.
