Following a report of discolouration on the river Cynon on Wednesday 07.02.2022, evidence samples were taken. The North Lagoon result of 712mg/l is significantly higher than 80mg/l.

Please note the Old Ponds result has been reviewed in a separate compliance form reference CAR_NRW0039495 and has been included only for information.

Enforcement Action

A warning has been issued within the compliance form for this isolated incident.

Actions

Prevent exceedances of the permit thresholds through careful use of flocculant in the lagoon system, and lowering the water levels in dryer weather when within the permitted thresholds.
