4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by Richard Morgan of SIMS Group limited.

Under **condition 1.1.3**, any persons having duties that may be affected by the matters set out in this permit shall have convenient access to a copy of it kept at or near the place where those duties are carried out.

During the inspection a copy of the permit and EMS were requested and were provided in the site office as required under the above conditions.

Evidence was also provided for Lindsay Washington's continuing competency certificate which meets **condition 1.1.4** where an operator must comply with the requirements of an approved competence scheme.

Under **condition 2.1.1** the operator is only authorised to carry out the activities specified in schedule 1 table S1.1.

Under the limits of **Schedule 1**, treatment activities of the operation were limited to the permitted types listed in Schedule 1 of the permit, with all waste treatment and storage being undertaken on impermeable surface as required. No non permitted wastes were identified during the site inspection.

During the inspection, it was noted that the operations were free from noise and vibrations likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales in line with **condition 3.4.1**.

Under **condition 4.3.1** of the environmental permit: The Environment Agency shall be notified without delay following the detection of: a) an malfunction, breakdown or failure of equipment or operating techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause a significant pollution. b) the breach of a limit specified in the permit; or c) an significant adverse environmental impact.

Under **condition 4.3.2**, the above information is required to be submitted to Natural Resources Wales in the Schedule 5 form in the period specified.

As discussed during the inspection, following the recent fire on site Natural Resource Wales has yet to receive a Schedule 5 notification form. As a result, this has been scored as a **category 4 breach** of permit **condition 4.3.2**.

Action – As agreed during the inspection, please complete and send the Schedule 5 form to Natural Resources Wales following the recent fire.
