4. Details of our assessment

This was an announced visit carried out on Thursday 17th February 2022 by Natural Resources Wales Hazardous Waste officer Kim Jones.

The purpose of the visit was to undertake a hazardous waste audit to assess for compliance against the Hazardous Waste Regulations 2005 and also a compliance visit for the permit to assess the waste operations of storage, labelling and segregation and staff competency.

From my discussions with Mr Kazlauskas it was understood that he had obtained a permit to be able to purchase damaged electric vehicles from auctions. The auctions will not sell damaged vehicles to any commercial site that does not have a permit.

Mr Kazlauskas does not have any employees and the workshop only has room for one vehicle and he is able to store a couple of vehicles outside but is not permitted by the landowner to have any more than this.

Therefore the activity being carried out is repair and sale of electric vehicles and there is not really any depolluting activity taking place.

The yard area is clean and tidy and the workshop is kept clean. Spare parts are kept in the locked shed next door to the workshop and a second shed has a small oil container on a bunded tray for waste oil, there is also a container for filters and batteries.



The site has good waste segregation and there is no mixing between hazardous and non hazardous waste types.

Hazardous waste consignment notes and waste transfer notes were readily available on site for inspection. As a site accepting hazardous waste you are required to complete section E on the hazardous waste consignment note and submit quarterly returns. During the visit we discussed the WAMITAB qualification and Mr Kazlauskas seemed unaware of the requirement for Technically Competent Managers to undertake the continuing competency test every 2 years. A compliance assessment report was sent on 15 March 2021 which deemed the qualification to be compliant at the time but stated that the certificate was due to expire on 29th May 2021. Therefore the site has not been compliant with an approved competency scheme which is a breach of the permit conditions and has resulted in a C3 minor assessment result.

Please register with WAMITAB to undertake the continuing competency test and provide NRW with evidence of this by the 11th April 2022.
