4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by Tony Samuel of Recycling Equipment (UK) Limited.

Under **condition 1.1.3**, any persons having duties that may be affected by the matters set out in this permit shall have convenient access to a copy of it kept at or near the place where those duties are carried out.

During the inspection a copy of the permit was requested and was provided in the site office as required under the above condition.

Evidence was also provided for Gary Samuel's continuing competency certificate which meets **condition 1.1.4** where an operator must comply with the requirements of an approved competence scheme.

Under **condition 2.1.1** the operator is only authorised to carry out the activities specified in schedule 1 table S1.1.

Under the limits of **Schedule 1**, all wastes must be treated, and stored prior to treatment within a building on an impermeable surface with sealed drainage to sump. With treatment operations limited to manual and/or mechanical sorting and/or separation, bulking up for onward transfer of permitted waste for the purpose of recovery and/or disposal.

During the inspection, it was noted that the operations was free from odour (**condition 3.2.1**) and noise and vibrations (**condition 3.3.1**) likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales.

Under **condition 4.2.2** within one month of each quarter, the operator shall submit to Natural Resources Wales the form made available for the purpose, the information specified on the form relating to the waste accepted and removed from it during the previous quarter.

Returns for Q1-Q3 2021 have been submitted and reviewed. An issue has been identified in the submitted waste codes used, 17 01 06 and 17 08 02 have been used in each quarter however these waste types are not listed within Table S2.1 of the permit.

Action – can you please confirm if these are clerical errors and the wrong waste codes have been used.
