Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This was a an unannounced follow up site inspection to check if the site had complied with the action detailed in the previous CAR form (CAR- NRW0038919) of installing a secure fence to stop waste leaving site and prevent unauthorised access. The due date of this action was 25/02/2022

The site inspection was carried out by the Regulating Officer for the site Kathryn Bradshaw and accompanied by Waste Regulation Officer Boguslawa Pierzchala.

There was no one on site at the time of our visit and the site was not operational. There were 3 coaches parked at the side of the de-pollution building which is not part of the permitted area.

The site was viewed from an adjacent field due to the difficulty of getting around all the vehicles.

There has been no progress on the removal of any of the vehicles in order to begin installing the infrastructure required to begin operations. The fencing that has been installed does not make the site secure and access could be gained and waste could escape at any time through this fencing. More suitable secure fencing must be installed before site operations commence.

Gareth Davies has enrolled on the WAMITAB course but has yet to complete it. No other TCM cover for the site has been arranged.

The following actions are required following the visit:

1. Confirm if 24 hour remotely accessible CCTV system has been installed/due to be installed
2. Confirm with evidence that the 3 coaches being stored adjacent to the de-pollution building are not waste. If they are waste vehicles then move them to within the permitted area.
3. Confirm who the TCM cover will be until Gareth Davies passes his course.
4. The temporary fencing to be replaced with permanent secure fencing which would prevent access and contain the waste on site. This must be done before operations start
