In CAR form dated 04/1/17 you were required to submit missing Q1, 2, 3, & 4 2016 waste returns and to implement a procedure to prevent this breach of your permit from occurring again. We have not received the requested waste returns or any for Quarter 1 and 2 2017 as per condition 4.2.2 of your permit. As a direct result of this continued failure to comply with permit condition 4.2.2 a CCS score 4 has been applied and as an effective procedure has not been implemented to prevent this breach of your permit occurring again a CCS score 4 has also been applied against condition 1.1.1 of your permit. Because of these permit breaches a site warning has also been applied to this CAR Form.

Actions Required by 23rd October 2017

1. You are required to submit the missing returns for quarters 1, 2, 3, 4 2016 and quarters 1 & 2 2017 to waste.returns@cyfoethnaturiolcymru.gov.uk by the 23rd October 2017.
