Sorry I didn't get back to you yesterday.

We believe that the site could apply for a low risk surrender and therefore pay the lower fee.

With regards to the CAR forms etc these are things we would review ourselves when the low risk surrender was applied for. Should you wish to have copies you would have to make a Freedom of Information Request or come in to have a look at the public register. Due to the age of the site there are likely to be a lot of inspection reports to send to you.

I am not sure what information you require for the EP History so if you could let me know I can have a look into it.
