Comments

During the walk around site I observed some WEEE waste being stored outside. Condition 2.4.2 of our permit states that "The storage (including temporary storage) and treatment of WEEE shall be carried out in accordance with the technical requirements of Annex III of the WEEE directive." Annex III of the WEEE directive states

"Sites for storage (including temporary storage) of WEEE prior to their treatment (without prejudice to the requirements of Council Directive 1999/31/EC):

- impermeable surfaces for appropriate areas with the provision of spillage collection facilities and, where appropriate, decanters and cleanser-degreasers,
- weatherproof covering for appropriate areas."

The WEEE was being stored on an impermeable surface. If any of this WEEE or its components are going to be reused then you will need to store it under a weatherproof covering as well. If the WEEE is just going to be sent off site to be shredded, i.e. at EMR or SIMS, then it does not need to be stored undercover. As I am not too sure what the intentions are with this WEEE I thought I should raise this and I will discuss with you during my next visit to site if it is an issue.

Environment Management System (EMS)

The Environment Management System (EMS) you submitted in November 2013 was discussed. Within the CAR form issued for my inspection on the 29th April 2014 I listed some improvements to the EMS. Due to illness these have not yet been submitted. During this inspection we discussed when these improvement would be done by. It was agreed that they could be completed and finished within a maximum of three months. I would therefore expect to receive these improvements by the 31st March 2015.

Waste Returns

Please be aware that your annual waste returns will be due by the end of this month. All waste returns must now be entered onto the new Natural Resources Wales forms and submitted to the new email address/address. NRW are no longer accepting waste returns submitted to us on Environment Agency forms. You can find details at the below website address
