Natural Resources Wales considers that the following conditions of the environmental permit have been contravened:

WEEE1.1.1 The licence holder is authorised to carry out the activities specified in schedule WEEE1, table 1.1 Licensed activities ("the activities").

Schedule WEEE1 – Operations

R3: Recycling or reclamation of organic substances which are not used as solvents, including composting and other biological transformation processes.	Technical Requirements for Treatment: Treatment consisting only of sorting, dismantling, separation, shredding, screening, grading, baling, shearing, compacting, crushing, granulation, or cutting of waste into different components for recovery.
R4: Recycling or reclamation of metals and metal compounds.	Treatment of WEEE: • must be carried in areas provided with a waterproof covering where appropriate; • must be carried out on an impermeable surface with sealed drainage with provision of spillage collection facilities and where appropriate, decanters and cleanser degreasers.
R5: Recycling or reclamation of other inorganic materials. The capacity of the site for hazardous waste subject to a R5 activity shall not exceed 10 tonnes per day. The maximum amount of waste stored pre or post-specified recovery operations shall not exceed 210 tonnes. No more than 50 tonnes of non-hazardous waste, per day, may be treated for the purpose of disposal. Total annual throughput of the site shall not exceed 24,999 tonnes.

In that greater than 210 tonnes of waste is being stored pre or post-specified recovery operations and waste is not being stored within the building at locations specified in Appendix D, drawing CRT/WML-04 of the working plan.

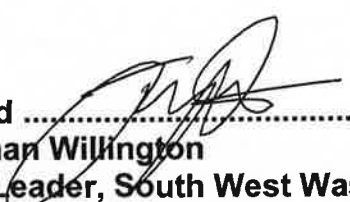
1.2.1 No waste other than those, which are specified in section 1.2 of the working plan and categorised below in Table 1.2A shall be accepted at the site.

Environmental Permitting (England and Wales) Regulations 2010

Regulation 36

Notes:

General

1. Failure to comply with this notice is an offence under Regulation 38(3) of the Environmental Permitting (England and Wales) Regulations 2010 and may result in legal action being taken against you.
2. Without prejudice to the requirements of this notice, failure to comply with a condition of an environmental permit is an offence and may result in legal action being taken against you.
3. You may wish to seek independent legal advice.

Appeal provisions

You are entitled to appeal against this notice under Regulation 31(2)(f) of the Environmental Permitting (England and Wales) Regulations 2010. Notice of appeal must be made within two months of the date of this notice. An appeal does not affect the requirements of this notice.

At the same time you must send a copy of the appeal notice and documents to us.

The required documents are:

a statement of the grounds of appeal;
a copy of any relevant application;
a copy of any relevant environmental permit;
a copy of any relevant correspondence between the appellant and the regulator;
a copy of any decision or notice which is the subject matter of the appeal; and
a statement indicating whether you wish the appeal to be in the form of a hearing or dealt with by way of written representations.

You may withdraw an appeal by notifying Welsh Ministers in writing and sending a copy of that notification to us.

Further information about making an appeal and the forms that you will need are available from the Environmental Protection Division.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) Order 2012.

You should note that the Natural Resources Body for Wales has been formed by bringing together the Countryside Council for Wales, Forestry Commission Wales and Environment Agency Wales. The Natural Resources Body for Wales has been empowered to exercise Welsh devolved functions since 1st April 2013 and has, generally, taken over the responsibilities of the Countryside Council for Wales, the Forestry Commissioners and the Environment Agency in Wales.
