**WHEREAS** on the 29 January 1993 the Alyn and Deeside District Council issued a waste disposal licence (now to be treated as a waste management licence) in pursuance of its powers under Part I of the Control of Pollution Act 1974 for the above named facility to Caird Environmental Ltd.

**AND WHEREAS** on the 13<sup>th</sup> September 1993 the relevant waste regulation authority modified the conditions of the said licence.

**AND WHEREAS** on the 1<sup>st</sup> April 1996 the powers and duties of all waste regulation authorities in England and Wales transferred to the Environment Agency ("the Agency") by virtue of section 2 of the Environment Act 1995

**AND WHEREAS** on 6<sup>th</sup> June 1997, 18<sup>th</sup> February 1998, 11<sup>th</sup> April 2003 and 25<sup>th</sup> March 2005 the Environment Agency modified the conditions of the said licence pursuant to Section 37 (1)(a) of the Environmental Protection Act 1990.

**AND WHEREAS** on the 27<sup>th</sup> January 2005 the Environment Agency transferred the said licence pursuant to Section 37 (1)(b) of the Environmental Protection Act 1990 to ASH Waste Services Ltd, Company Registration Number 04691923

**NOTICE IS HEREBY GIVEN** that the Agency modifies the conditions of the said licence in accordance with Section 37 (1)(b) of the Environmental Protection Act 1990 and as set out in the Schedule attached to this notice.
