AND WHEREAS on 6th June 1997, 18th February 1998, 11th April 2003 and 25th March 2005 the Environment Agency modified the conditions of the said licence pursuant to Section 37 (1)(a) of the Environment Protection Act 1990.

AND WHEREAS on the 27th January 2005 the Environment Agency transferred the said licence pursuant to Section 37 (1)(b) of the Environment Protection Act 1990 to ASH Waste Services Ltd, Company Registration Number 04691923

NOTICE IS HEREBY GIVEN that the Agency modifies the conditions of the said licence in accordance with Section 37 (1)(b) of the Environmental Protection Act 1990 and as set out in the Schedule attached to this notice.
