## **BACKGROUND:**

This site received planning consent issued by Alyn & Deeside District Council in March 1980, for construction of a skip bay.

There were no conditions related to the operation or closure of the site.

The site was issued with a Waste Management Licence (EAWML/37070) originally in June 1993 which was later modified in August 1997, 1999 and 2011. The original types of waste that could be accepted at the site were restricted to civic amenity waste (bulky household waste) but later amended to construction and demolition wastes, waste oils, non-hazardous metal wastes, and degradable household wastes, all of which had to be delivered by householders.

The maximum annual quantity that could be accepted was 24999 tonnes with a maximum storage amount of 100 tonnes.

Wastes were stored in suitable containers, (oil in double skinned tanks) prior to regular removal to the point of disposal.

The site consisted of a concrete slab with rear and side concrete walls, and a brick wall (surmounted by razor wire to) the Sandy Lane aspect. The site was further secured by two metal gates and substantial gate posts.

All wastes were placed into containers with waste oils being placed directly into the oil storage tank. No waste was allowed to remain on the concrete slab, apart from any materials that had spilt for a short time during loading or unloading of the containers.

The site has been closed for the reception and storage of waste since mid-2014.

## **REMEDIATION WORKS:**

Saltney Closure report

All the concrete (slab and walls) have been broken out and removed to below formation levels and replaced with clean top soil. The brick wall has been demolished and the razor wire removed. The metal gate posts and gates have been reclaimed for future re-use.

There were no drains or tanks to clean out or remove.

Documentation demonstrating the legal disposal of the concrete and brick is included as document A

The topsoil was seeded during the autumn of 2015 so as to restore the site as a continuation of the grass verge to the Sandy Lane roadway. It will then be maintained along with the other verges (Document D)


