Barry Docks Site Visit – JM Envirofuels (EPR/AB3690CP) – 24/05/2019

Environment officers Craig Coleman & Lara Moggridge attended JM Envirofuel's facility at ABP, Barry Docks, Vale of Glamorgan on 24/05/2019 to conduct a site inspection. The site manager was present during the visit. The weather was clear, and the site was quiet at the time of inspection.

(C3) Materials Acceptance

There is currently minimal waste being housed on site. What material that is there is waste wood that is waiting to be transferred for treatment at another facility.

(D1) Site Security

The site has surveillance equipment that is monitored offsite 24 hours a day. The site is surrounded by fencing and a body of water; access to the facility is via a gate that is locked when the site is not operational.

(F3) Dust/fibres/particulates and litter

The overall condition of the site was very clean, there was no litter on the floor and the boundary surrounding the site was also clear of litter and debris from site activity.
