4. Details of our assessment

This Compliance Assessment Report follows a familiarisation visit for the new Site Responsible Officer accompanied by Metal Improvement Company's Business Unit Manager and new HSE Compliance Officer.

A general overview of the site's operations and how it amalgamates into the overall Airbus Operations on the site was presented prior to the site walkover.

The directly associated activity carried out by MIC. This involves surface treatment of metal components by means of shot blasting to shape the surface and to condition it by producing indents, which increases resistance of the surface to tension cracking. This activity is controlled by its own permit. MIC also operate a small heating plant, which is part of this installation but is considered to have an insignificant environmental impact.

The metal components are parts of the Airbus Wings and components plant at Broughton, whose main purpose under a separate permit is surface treatment and coating plant, effluent treatment plant and most of the wing manufacturing.

Emissions to Air

Emissions to Air on site are produced mainly via the peening processes, which will be steel dust from wear of the shot balls. Abatement systems were highlighted during the site walkover along with the product storage locations.

Gas fired heaters (A1-A12) produced emissions
A13 and A14 linked to the peening processes.

Particulates to Air (mg/m³) ELV is 20 and the frequency of monitoring is annual for both A13 and A14.

There are no emissions to both land, water and sewer is allowed under the permit.

Waste Handling & Storage

The main wastes on site are

Steel and Aluminium Dust - (classed as Hazardous)

Spent and Sub-standard shot, packaging, tapes. Decontamination liquids, compromising water, weak phosphoric acid and de-watering oils.

Storage locations and methods were assessed as compliant during walkover.
