4. Details of our assessment

No waste deployments have been made under this permit so far. The digestate being produced by the Pencefn AD plant (EPR/BB3794CF) is currently assessed as a 'non-waste' as no controlled waste is being used in the facility. Should this status change then there will be a requirement to spread the resultant digestate to land under the conditions of a mobile plant permit and inline with an approved waste deployment demonstrating an agricultural

benefit. The same would apply should you decide to spread biowaste from another source under the conditions of this permit.
