We have reviewed the following documents:

- Bryn Posteg Landfill compost pad leachate lagoon construction works method statement and construction quality assurance plan Ref ARM/BP/CP/CQA/2.00/2020[Revised 18 January 2022;11 &14 October 2021]
- Comp lagoon Amend03 [Document number BP/COMLAG/AMEND03] Amendment to 18 January 2022 Drawing Reference updated: Extra pipe added to drawing
- Drawing-Bryn Posteg proposed composting compound lagoon REV4

These documents refer to a proposal by the operator to install an additional 150mm runoff pipe to the lagoon adjacent to the compost slab ramp access.

NRW considers the proposed amendments in the documents referred to above to be acceptable.

The document Bryn Posteg Landfill compost pad leachate lagoon construction works method statement and construction quality assurance plan Ref ARM/BP/CP/CQA/2.00/2020[Revised 18 January 2022;11 &14 October 2021] is confusing as it contains lots of hand-written notes, redactions and refers to amendments/ revisions which are contained in separate documents. This document will be placed on the public register and will be used by the contractors during construction. For clarity, we request that the operator completes ACTION 1 before construction begins.

ACTION 1: Before construction begins, provide NRW with a finalised and consolidated version of Bryn Posteg lagoon construction works method statement and construction quality assurance plan which incorporates all of the amendments made 11 -14 October 2021 and 18 January 2022.
