Although the discharge from the asset was not as a result of rainfall or snowmelt as specified in condition 2.3.2 (a). NRW are satisfied that this was an emergency discharge as described in schedule 1 table S1.1, pump failure. DCWW acted quickly to mitigate the impact to the watercourse. photos provided show no visible impact.
