4. Details of our assessment

CAR issued as follow up to WIRS 2104705

Incident reported to NRW via a member of the public, Dŵr Cymru investigations at the time suggest that one of the two pumps on site was out of action which led to non-compliant short duration spill(s). Investigations also confirmed that these spill(s) were not detected by the alarm system on site and as such did not alert Dŵr Cymru to the problem. The findings indicate that both the maintenance and alarm system functionality at this asset may be a problem. NRW request that the following actions are taken by Dŵr Cymru;

1. Increase maintenance frequency on asset.
2. Provide maintenance records for period 2020-present.
3. Provide EDM data for period 2020-present.
4. Investigate failure to alarm when spilling and present findings to NRW.

These actions should be completed by 30/04/2022.
