4. Details of our assessment

Unannounced site inspection undertaken by Dave Ellar of

(NRW). Dave Ellar met with Shaun MacKay of Pendragon Waste & Skip Hire Ltd and discussed the findings of the visit.

General:

The site was busy but appeared to be well managed. Good segregation of wastes was observed, and no noncompliance's were recorded. It was raining heavily during the inspection and had been wet for some time, the hardstanding was very wet and muddy but was holding up well. All site runoff appeared to be draining to the settlement lagoon. All wastes were being sorted and stored within the building and the only wastes outside were permitted 'specified' wastes or waste in skips either awaiting removal of site or to be tipped in the building.

There was a slight oil sheen visible on the standing water in parts of the yard but no obvious source was found, the lagoon was checked but was clear of oil. Shaun MacKay explained that some maintenance of plant had recently been carried out and suggested some residual oil may have washed off a machine in the rain. He assured the officer that plant checks would be carried out to ensure no oil leaks were occurring. A half full plastic container (with top off) was present in the yard next to a machine. Shaun Mackay assured the officer that it would be taken back inside the building straight way.

Discussion:

Shaun MacKay raised the issue of a recurring noncompliance that has been identified in previous visits. During previous visits some waste has been observed on a concrete pad outside of the treatment building, this is a breach of section 2.3 of the permit and has previously been scored as a category 3 noncompliance. No waste was seen on the pad during this visit but Shaun Mackay explained it could still be an issue. Pendragon want to utilise the pad to tip waste on before it is taken into the building to be treated however this is not allowed under the current standard rules permit. A permit variation was discussed but the only option would be to vary the standard rules to a bespoke permit which may be a costly and lengthy option. It was decided that the better option would be to extend the building to cover the section of concrete pad. This would be acceptable under the conditions of the permit. Shaun MacKay stated that he would keep NRW updated when a decision was made.
