We met Christopher Edwards and Jack Alderdice from Welsh Water on site at Trellech Waste Water Treatment Works.

The permitted limit for ammonia in the discharge at this works is 17mg/l. There had been two Look Up Table exceedances for ammonia at this works. One exceedance on 1/10/2017 where the level of ammonia was 18.75mg/l and another exceedance on 26.11.2017 where the level of ammonia was 23.9mg/l.

Christopher had already asked for a flows and loads report to be carried out in response to the two exceedances referred to above. We saw black staining on the gravel media in the filter beds which may suggest that the works is being overloaded. Please can you send the report to neil.griffiths@cyfoethnaturiolcymru.gov.uk by 28.02.18

The distributor arms over the filter bed were not level which was causing an uneven distribution of effluent onto the filter bed below. This may be reducing the level of treatment being provided by the works. Please ensure that the filter arms are levelled by 28.02.18. This has not been scored as a non-compliance as there is no condition that covers this issue in the permit.
