I visited the site for the first site visit and was met by the manager and owner Mr Paul Cassemis. We had a look at all of his paperwork with regards to the operation of the site and the future qualifications that are needed and being worked on. He is in the process of getting his WAMITAB and this will be completed within the year. We then looked around the yard area where he stores all his asbestos.

CAT 3 Breach Standard rules SR2008N09. Storage of asbestos outside of sealed containers.

Your standard rules permit states that all asbestos material should be stored within sealed containers. When I attended the site there were bags of asbestos being stored at that time outside of sealed containers. we spoke about this and Paul stated that he would have it moved into the sealed containers straight away and that all of that type of asbestos would be stored at all times within the sealed containers from then on. The bonded asbestos material would also need to be stored within the sealed containers as per the standard rules SR2008N09. This states that the only permitted hazardous waste is asbestos which must be double-bagged and stored within secure, lockable containers.

Action:

Ensure that all asbestos onsite and which comes to site in the future is stored within secure lockable sealed containers. I will visit site next week to ensure that this is being complied with.
