The following comments are noted:

NOx emissions from Therminol Pyrolysis Furnaces

The furnace upgrade work in accordance with the requirements of IC35 was last confirmed as scheduled for Q2/2022. As mentioned in the Annual Activity Performance Review the exact timing can not yet be confirmed due to global supply issues. NRW should kept informed of any further developments. Compliance with the NOx limit of 200mg/m3 for A26 and A27 will apply following completion of the work.
