4. Details of our assessment

A routine site inspection was undertaken on Tuesday 15th March 2022. Natural Resources

Wales officer, David Morgan, was accompanied by the Operator, Richard Jenkins.

No non-compliances were recorded against the Environmental Permit. During the inspection, the following observations were made:

Operations

It is noted that operations (deposit of waste in quarry) are currently on hold due to matters associated with the planning permission. The site has a rolling planning permission and is currently being determined.

All wastes previously deposited on site appear to be compliant with the list of accepted wastes in the Environmental Permit.

ACTION: Please provide a statement of current planning status and scope of proposed works when planning is determined (dates for completion, waste volumes etc.).

Site Security

Following an inspection of the quarry, an assessment was made of the boundary fence. One section of the fence appeared to be leaning and may, at some point, fall down. Please ensure the fence is maintained to prevent unauthorised access to site.

It is noted, that owing to the hedge growth and vegetation in this area, access to site is unlikely.

ACTION: Ensure works are undertaken to maintain site boundary fencing.
