Site Q3 July-Sept 2018 waste returns has been reviewed to check compliance with Schedule 9 (Part 2) of The Environmental Permitting (England and Wales) Regulations 2016. This is because the site is a notified Material Facility that is subject to the condition of complying with measurement and reporting requirements in the above regulations.

### Inputs

No compliance issues were identified with the reported number of samples and weight taken per supplier of mixed waste material. One fewer sample was reported as taken for the supplier on row 4 but this could be a timing issue with reporting.

### Outputs

A minimum of one sample must be taken for every 60 tonnes of specified cardboard outputs.

The reported specified cardboard outputs on row 18 report taking three fewer samples than the minimum requirement (15 instead of 18).

**This is a breach of Schedule 9, Part 2, paragraph 5 of the Environmental Permitting (England and Wales) Regulations 2016 and has been recorded as a category 4 non compliance.**

Please re-submit the waste return if any errors in reporting are identified following this CAR.
