At 13:35 on 15th June 2018 your site was visited as part of the routine assessments for compliance, your new regulatory officer, Richard Palmer, was in attendance with Senior EO Lara Moggridge who met with Paul Dare and Helen Dare, owner and employee of KDK Metals. Thank you for taking the time to discuss and demonstrate your activities on site.

Your operation consists of a newly permitted ELV site for scrapped cars, alongside a metal recycling yard operated under a variety of registered exemptions.

This visit was an initial site inspection and the following points summarised below were discussed.

Technical Guidance, EMS, TCM, Waste returns, Compliance/CCS Scores, CAR forms, Public register, Duty of Care, Hazardous Waste Regulations, Permit changes and ELV Depollution Regulations were talked through with Paul and Helen by NRW site officers. A copy of this document and the notes made is available from NRW upon request, and if agreed by KDK Metals.

Assessment of the permitted activities was not undertaken as the site was not yet operational with no ELV depollution currently taking place on site.

The conditions were overcast but dry.
