Introduction

This inspection was conducted as part of the regular compliance inspections required throughout the year. It was also an opportunity for Officer John Jowett to complete a site handover.

Permit Holder Mr Michael Edwards stated that he had successfully completed the WAMITAB course required to prove technical competence but I am as yet to receive his certificate and would like it sent to me within the next 7 days.

We discussed ongoing issues with the pipes connecting to the main sewer and that the problem would be fixed by Dwr Cymru Welsh Water towards the end of the year.

Compliance

During the site inspection, it was found that there were a number of areas of concern on the back area of the yard. There were a number of vehicles there which were obviously ELV. Some of these vehicles have been not been de-polluted and were being stored on an area which did not have sealed drainage.

C4) Management-Storage, Handling, Labelling and Segregation,

Permit Condition 2.2.1 referring to Table 2.1 'Specified end-of-life vehicle storage and treatment operations', states that a maximum storage capacity of 10 vehicles stored on an impermeable pavement with a sealed drainage system. **You have therefore been scored a Category 3 breach against this condition, as it is reasonably foreseeable that you could cause a significant impact to land and ground in the event of a large spillage.?**

Action

As mentioned above the back area of the yard needs some significant management and improvement before the beginning of September.
