Permit Condition 2.3 referring to section 2.3 and having a technically competent person having completed the WAMITAB course. **You have therefore been scored a Category 3 breach against this condition.**

Action

We spoke about this on site to Mr Edwards and he stated that he would be putting a member of his staff on this as soon as he can, can you confirm the date or that you have got the services of a consultant hired in as a TCM to help alleviate the problem.

On looking at the back end of the yard there were a few oil/petrol spills in lots of places.

E2) Emissions-Land and Groundwater

Permit Condition 5.1.1 referring to section 5.1.1. All vehicles used on the site by the operator, and all plant and equipment used on this site in connection with specified waste management operations, shall be operated and maintained with the objective of preventing potentially polluting leaks and spillages of wastes or other potentially polluting materials which are to be used in combination with those wastes in the specified waste management operations. **You have therefore been scored a Category 3 breach against this condition.**

Action

We spoke to Mr Edwards about this problem and he stated that he would speak to his drivers and get them to park the vehicles on more level ground to ensure this problem doesn't happen again.
