## **STATEMENT OF SITE CONDITION**

### **Application Stage**

Based on the environmental setting and historical land use information gathered at application stage there appears to be limited potential for historical anthropogenic contamination. This is because the site has no recorded formal land use but has formed part of the wider industrial estate for several decades.

The site currently comprises hardstanding used for the storage and transfer of whole tyres. This activity is not inherently polluting and does not actively generate leachate. The land beneath the site is separated from the waste activities by compacted hardstanding. This means that there is limited pollution potential under normal conditions and that there is an unsaturated layer between the site activities and underlying groundwater in the secondary aquifers.

### **Permit Surrender**

This Site Condition Report and Statement should be updated during operation and utilised at Permit surrender.

# 1 INTRODUCTION

## 1.1 Scope of Report

TD Tyre Recycling Ltd (TD) seeks to secure a bespoke Permit from NRW to operate a Tyre Recycling Facility at their site in Johnstown, Carmarthenshire (see Figure 1). Small amounts of waste agricultural plastic wrapping will also be accepted.

As part of the Permit application, NRW has requested TD to prepare a Site Condition Report (SCR). Geotechnology Ltd. has been requested by TD to assist with the application and to prepare the SCR. Details of the application are summarised in Table 1-1.

At this stage, the objective of the SCR is to document the site history and establish the potential for legacy contamination at the site. This stage is aimed at documenting the site history, identifying potential contaminative uses and providing a framework and justification for potential future intrusive site investigation and sampling. This SCR will need to be routinely reviewed and updated so that a full SCR is available at the time of Permit surrender. Information including incidents and records of compliance with the Environmental permit will need to be gathered during the operation to achieve Permit surrender and ensure the SCR remains current.

## 1.2 Report Limitations

This report relies upon information supplied by third parties. Geotechnology has had no input to the development of this information and therefore cannot confirm its accuracy. The ground conditions beneath the site have also not been intrusively investigated.

## **2 DESK STUDY AT APPLICATION STAGE**

### **2.1 Information Sources**

To assist with the collation of baseline information relating to the site, Geotechnology has purchased an electronic Envirocheck report from the Landmark Information Group

Within this SCR, the information obtained from Envirocheck is presented in the following Appendices:

- Appendix 1 Envirocheck Report
- Appendix 2 Historical Ordnance Survey Maps

Each appendix contains a datasheet summarising information which is also presented on a series of plans included in each appendix. On each plan the centre of the site is indicated by an 'X' with buffers centred on this position. Distances and directions to points of interest and features are based on their relative position to the centre of the site.

### **2.2 Site Setting**

As shown on Figure 1, the proposed operation is located southwest of the town of Carmarthen between Johnstown and Llanllwch on Cillefwr Industrial Estate at Grid Reference 239050, 218890. Approximately 600m north of the site is the A40 running east-west and ~400m north is a main railway, also running east-west.

The site is located on Cillefwr Industrial Estate which provides serviced space for a range of mainly waste, mechanical, retail construction and light industrial uses. The TD site is at the furthest southwestern limit of the current industrial estate and the end of Cillefwr Road West, to the rear (south) of a Mechanical Garage known as Gordons Garage. Access to the hardstanding site is off Cillefwr Road West that forms a T-junction, with the southern arm providing access to TD Tyres and the opposite (northern) arm leading to CRES waste management. The main spine of the T-junction leads back into Cillefwr Industrial Estate.

Along the southern boundary of the site the densely vegetated ground slopes upwards to residential properties on the northern side of Alltynap Road. The northern facing gardens of these properties directly butt up against woodland that runs along the southern boundary of the site and which also extends part way around the western and eastern boundaries. Beyond the trees to the west is currently open farmland.

Many of these key features are shown on Figure 2.

A list of contemporary trade entries close to the site is given in the Envirocheck report in Appendix 1.

### **2.3 Current Site Use**

As one of the few tyre recycling facilities in West Wales, the site provides a key outlet for waste tyres in South Wales for a range of clients.

The site is currently hardstanding and used for the storage and transfer of vehicle tyres.

## **2.4 Previous Land Use**

As part of the Envirocheck package of information, historical maps dating from 1888 to the present day have been purchased.

Examination of these Ordnance Survey Plans reveals that in 1888 the site lay in a largely rural setting comprising fields, with nearby dwellings named as Ty-Newydd, approximately 900m southwest of the village of Johnstown. Scott's Wood is close by to the southeast of the site and Llanllwch Corn Mill and Pond lie some 200m and 300m to the west respectively. The Great Western Railway can be seen 400m to the north of the site and an "Old Gravel Pit" is indicated some 180m northwest. A stream is shown traversing northeast to southwest some 200m northeast of the site and is a tributary to the River Towy located approximately 1.5km east of the site.

The site and surrounding area remain largely unchanged until around 1983 with the construction of Cillefwr Industrial Estate to the northeast. By the 2006 edition, the site has become part of this estate. The A40 to the North is first shown on the 1990 plan.

## **2.5 Environmental Setting**

To assist with understanding the environmental setting of the site Geotechnology has undertaken a review of publically available information alongside the information included in the Envirocheck Report. A summary is presented below with further information provided in the appended Envirocheck Report.

## **2.6 Superficial Deposits and Geology**

The Envirocheck report indicates the site is underlain by solid geology comprising sedimentary rocks belonging to the Arenig Beds of Ordovician age (~470 million years).

The British Geological Survey Interactive viewer shows the site to be underlain by superficial deposits comprising fluvioglacial sands and gravels.

### **2.6.1 Mining and Quarrying**

The Envirocheck Report states that the site does not lie within an area which may be affected by coal mining activity. Other recorded mineral sites can be seen on the Envirocheck data sheets in Appendix 1.

### **2.6.2 Hydrology**

The site lies within the catchment of the River Towy which flows northeast to southwest some 1.5km east of the site.

The nearest surface water feature is a stream 200m north, downslope of the site. The site is not considered to be susceptible to flooding.

---

### **2.6.3 Hydrogeology**

NRW has defined Source Protection Zones (SPZs) for 2000 groundwater sources such as wells, boreholes and springs used for public drinking water supply. These zones show the risk of contamination from any activities that might cause pollution in the area. The closer the activity, the greater the risk. The maps on the Agency website include three main zones (inner, outer and total catchment). The Agency use the zones in conjunction with their Groundwater Protection Policy to set up pollution prevention measures in areas which are at a higher risk, and to monitor the activities of potential polluters nearby. The zones established are as follows:

- Zone 1 (Inner protection zone) - Any pollution that can travel to the borehole within 50 days from any point within the zone is classified as being inside zone 1.
- Zone 2 (Outer protection zone) - The outer zone covers pollution that takes up to 400 days to travel to the borehole, or 25% of the total catchment area – whichever area is the biggest. This travel time is the minimum amount of time that the Agency think pollutants need to be diluted, reduced in strength or delayed by the time they reach the borehole.
- Zone 3 (Total catchment) - this is the total catchment needed to support removal of water from the borehole, and to support any discharge from the borehole.

According to the Envirocheck report, the site is not located in any of these zones but is underlain by secondary aquifers in the sand and gravel superfcials and then the underlying sedimentary rocks. These provide some of the baseflow to the local surface water catchments and are considered to be of medium vulnerability.

### **2.6.4 Private Water Supplies**

According to the Envirocheck report there are no private water abstractions in close proximity to the site.

### **2.6.5 Protected Sites and Landscapes**

According to the Envirocheck report there are 10 Protected Ancient Woodland Sites within 1km of the site, the nearest being some 90m southeast of the site.

### **2.6.6 Proximity to Historical or Active Landfills**

There are three Licensed Waste Management facilities within 1km of the site, the nearest being a Transfer station operated by CRES on the opposite side of the access road.

Potentially infilled land (non-water) is indicated some 217m and 904m north of the site at two old quarries. There are 9 entries for potentially infilled land (water) within the 1km buffer zone, the closest approximately 200m north at the site of an unknown pond.

There are two Registered Waste Transfer Sites located 279m and 342m northeast of the site. There are no known restrictions on waste sources at these sites.

Only one historical Landfill Site has been located within the buffer zone, some 734m west of the site. Here the specified waste included Inert, Industrial and Household waste.

### **2.6.7 Ground Stability Hazards**

The Envirocheck Report highlights the site to have the potential for Collapsible Ground Instability, Landslide Ground Instability, Running Sand Ground Instability and Shrinking or swelling of Clay Ground Instability.

### **2.6.8 Radon Affected Areas**

The Envirocheck Report states that the site is in an Intermediate probability radon area and that no radon protective measures are necessary in the construction of new dwellings or extensions.

### **3 INTRUSIVE INVESTIGATION AT APPLICATION STAGE**

An intrusive investigation of ground conditions beneath the site has not yet been undertaken.

During the operation of the current tyre operation there have been no pollution incidents or fires.


