### Introductory note

#### **This introductory note does not form a part of the notice**

The following notice gives notice of the variation of an environmental permit.

The permit has been varied to allow the operator to accept wastes types under EWC Code 20 01 99. The waste to be accepted has been included in Table 3.1 and will include dog faeces, incontinence pads, nappies, sharps (collected from public conveniences) and all non healthcare materials. The materials will be stored in lockable containers or a hazardous materials safe and will be on an impermeable pavement served by a sealed drainage area.

The schedules specify the changes made to the original permit.
