Environment Officer Craig Coleman completed an audit on the ELV process at Abba Scrap on 04/04/2018 to assess the management and compliance with The End-of Life Vehicles Directive 2000/53/EC. This assessment included ensuring minimum infrastructure requirements to prevent and minimise pollution at the site, the storing and treating ELVs and the depollution and dismantling process to promote recycling and recovery. There were no breaches recorded.

The audit was undertaken on a Blue Ford KA, registration CF53 HGX in the ELV Depollution Bay of the site with the depollution process being completed by Mr Garry Taylor & Clifford Evans, the technical competent manger on site was Mr Colin David Jenkins. Mr Taylor and Mr Evans completed the process in full accordance with the ELV regulations. The airbags failed to deploy during the depollution process at no fault of Mr Taylor or Evans, the detonators were then removed from the vehicle. No parts of the vehicle contained mercury, and the catalytic convertor was maintained as part of the engine block

The fluid containment was all individualised between the different pollutants that were extracted from the vehicles; and all oil containers were double banded. The surface of the workshop was comprised of impermeable concrete and in good condition, the drainage on site flowed in to an interceptor and there were spill kits present throughout the site.

Please thank both Mr Taylor and Mr Evans for taking the time walk me through the depollution process and for the thorough explanations of their working methods.
