Tony Bruten attended site on Tuesday 25th July 2017 and met with the owner David Jenkins.

The site appeared in good condition and was generally compliant with the conditions of the permit. There was only one small issue that being an allocated Technically Competent Manager (TCM) for the site. Details of this will be listed below.

Parts of permit assessed.

A1 conditions specified by permit. The site was clean and in good condition with drainage to sealed interceptor. All depollution was carried out inside a building with impermeable surface with sealed drainage.

C1. Staff Competency. It was explained that the TCM for the site was Nicolas Brannan (NB) who is based on the adjacent premises (Merthyr Borough Recycling). Contact was made with NB and we are awaiting written confirmation from him that he will be the responsible TCM for your site. Having checked the WAMITAB database there is a requirement for NB to attend a WAMITAB Continuing Competency in order that his WAMITAB certificate is in compliance.

**Breach of Permit conditions** 2.4.1 Requirement for suitably trained member of staff (e.g. WAMITAB qualification)

and 2.4.4 Attendance of technically Competent Person.

These breaches are as a result of the nominated TCM not having an in date certificate.

**Requirement.** TCM for site Nicolas Brannan required to attend WAMITAB Continuing Competency training and attain relevant qualification.

C3. Material Acceptance. No Breaches identified.

C4. Storage, handling, labelling and segregation. No breaches identified.
