Both Marc and Stephanie Davies are currently undertaking the WAMITAB qualification and as part of the assessment process was being observed by the WAMITAB assessor (Geoff Griffiths of Brightwater Training) for the initial part of the audit.

The site carries out daily monitoring for temperature using a thermocouple probe and for moisture using the "squash-test" during stabilisation. Weekly monitoring is carried out for the sterilisation phase. The monitoring report for batch #17 was requested and the operator subsequently submitted the report on the 7th October 2016. These complete records reflect the operators statements regarding the monitoring process and show that batch #17 met the required temperatures and time-scales for sanitisation and stabilisation.

The temperature probe is sent away annually for calibration, it was last calibrated by Dry-it-Out in April 2016. In between the annual calibrations it is calibrated in-house.

Monitoring records are kept for a minimum of two years in order to meet the requirements of PAS100 accreditation. The monitoring process as a whole is a requirement of the PAS100 accreditation process and therefore the EMS will refer to this process. The EMS is currently being revised to be based on the NRW Toolkit EMS.

An inspection of the composting pad was undertaken, there was between 400 & 500tonnes of green waste on-site and no evidence of non-conforming wastes. There were three batches of compost in progress at the time and the final product appeared to be of good quality.
