4. Details of our assessment

An Operator Monitoring Assessment (OMA) for emissions to air was undertaken following a desk top review of documentation submitted by the Operator during Q4 2021. A follow up site visit was undertaken on 17 February 2022.

The site was well managed, ordered and tidy at the time of the inspection.

Air emissions are generally well managed. A few minor improvements have been identified relating to the Operators EMS and staff awareness in relation to emissions and permit requirements. Further details of the OMA assessment can be found in the accompanying document *2022.02.17_OMA_Lloyds*.

Emissions testing at the facility is required annually and this is undertaken by an MCERTS accredited contractor.

During the site visit the platforms and monitoring ports were viewed and these were in good order. The monitoring ports have been retrospectively installed due to the age of the plant. The monitoring contractor has identified sampling location restrictions and has implemented sampling deviations, these are identified within the reports and are acceptable to meet the standard.

Advice and guidance: If any of the lines are to be replaced in the future then the Operator should consider the location of monitoring ports as part of this.

The emission points are to the rear of the building and Officers queried whether the location of these vents were suitable. Officers are awaiting feedback from internal colleagues regarding the suitability of these emission points and will feed back to the Operator once further information has been obtained.

The following actions are highlighted within the OMA.

Action: Ensure approvals relating to the SSP and any deviations are documented and saved.

Action: Establish a written procedure for the auditing of MCERTS contractors and their activities during monitoring events.

Action: Add further detail into your existing procedures to document how any non-compliances would be addressed.
