At 11:00 on 03rd July 2018 your site was inspected as part of the routine assessments for compliance, your new regulatory officer, Richard Palmer, was in attendance with NRW Environment Officer Tony Bruten who met with Mark Robinson, Owner/Operator of Recycled Stone & Soils Ltd. Thank you for taking the time to discuss and demonstrate your activities on site.

Your operation consists of an Waste Treatment facility to produce soil and stones.

The parts of the permit that were reviewed were;

C1 Staff Competency; C2 Management Systems and Operating Procedures - No Action

All waste returns were accurate and up to date and TCM qualifications up to date and readily available. One issue was that there was a lot more waste coming in than out, in fact waste out was recorded a 0 tonnes, so waste cannot be continuously deposited at site and 'waste piles' must be removed rather than being allowed to build up and said to be 'product'.

Other issues,

The new instalment of a Compost treating facility was discussed with Officers whilst on site so please keep us informed of these developments as a permit variation and infrastructure improvement is likely to be required prior to commencing this activity.

Also the Permit boundary on the current NRW Permit is showing a deviation from the site map presented on site, this will need to be amended via our permitting team to show the correct site boundary.

Noise and Odour were considered, and found to be of no concern. The conditions were overcast but dry.
