Environment officer Nessa Dearle completed a site inspection on the 30/01/2017, to assess compliance with your environmental permit. The weather was cold and dry at the time of inspection and waste was being accepted on site. I was shown around site by Dean Gill, the site manager.

Thank you for taking the time to show me around site. The site appeared clean and well managed at the time of inspection, however one problem with the site infrastructure was detected. One breach was noted while on site. This breach and advice and guidance is outlined below.

Breaches

B1) Engineering to control emissions

Table 2.1 of your permit outlines that "Non-hazardous waste must be kept on an impermeable surface with sealed drainage". It was noted on site that the impermeable surface has become significantly damaged throughout the site. As such the cement is not adequately serving as an impermeable surface for the storage and treatment of wastes.

Action: As discussed on site, new cement will need to be put in place to improve the quality of your impermeable surface. While on site you advised that you had plans in place to repair this cement surface within the next 2 months. Therefore, NRW will implement a 2-month timeframe to have these repairs made. A follow up visit will be completed to ensure that these measures have been put in place.

Notes

While on site, we discussed reports that had been received by NRW of waste leaving the site boundary and falling from vehicles during transport. The site appeared tidy and no evidence of waste outside of your

permit boundary was seen at the time of inspection. Thank you for showing me the measures that you have in place to prevent waste escaping from lorries during transport. Please ensure that measures are used at all times to prevent litter leaving your site and during waste transport.
