Environment officer Nessa Dearle completed a site inspection on the 16th of April 2018, to assess compliance with the environmental permit. I was accompanied on site by the technically competent manager, Dean Gill.

Thank you for taking the time to show me around. The site appeared well managed and tidy at the time of the inspection. However, as discussed, improvements to site infrastructure are required to achieve compliance with your permit. Relevant advice, guidance and breaches are outlined below.

Breaches

B1) Engineering to control emissions, Category 3 breach scored.

Condition 2.1.1 of your permit outlines that the "holder is authorised to carry out the activities specified in schedule 2, table 2.1". **Table 2.1** outlines that "non-hazardous wastes must be kept on an impermeable surface with sealed drainage system".

As outlined in the previous CAR form the impermeable surface remains damaged and does not meet the requirements of your permit. The impermeable surface is damaged throughout the site and as such cannot effectively control emissions from the site. Standing water could be seen on site, showing that the drainage system is not working effectively.

Action: Following my previous visit, I assigned an agreed deadline of 2 months to have the surface repaired. However, you have advised that due to poor weather conditions the improvements works were not completed. A new deadline of two months has been agreed, as such NRW requests that the surface be fully repaired by the 19th of June. A follow up inspection will be completed to ensure that this action has been complied with.

Notes

On site you discussed the acceptance of hazardous waste on site. Your permit only includes the

acceptance of non-hazardous waste codes, as such you are non-permitted to treat or store any hazardous waste on site. If any non-permitted wastes or hazardous wastes get accepted amongst permitted wastes, then these should be placed in a quarantine area, segregated from permitted wastes.
