NOTICE OF MODIFICATION OF WASTE MANAGEMENT LICENCE

WHEREAS on 31 March 1994 the Montgomeryshire District Council granted to you a Waste Disposal Licence, now to be treated as a Waste Management Licence, Reference Number 13/93 relating to Bob Lowe Car Breakers, Car Breakers Yard, Nr Catchems Inn, Guilsfield Road, Welshpool, Montgomeryshire, SY21 9BN subject to the conditions set out therein and in any subsequent Modifications.

NOTICE is HEREBY GIVEN that the Environment Agency ("the Agency") modifies the said conditions as follows:-

The following Conditions attached to Waste Management Licence Reference Number 13/93 shall be deleted,

Condition Number(s): J.1, J.2, and J.3

and the attached Conditions, Waste Management Licence Reference Number 13/93 shall be substituted.

New Condition No: J.1

- J.1.1 A record shall be kept of all wastes received and of all materials (wastes and recovered materials) removed from the site. The records shall include the following for each vehicle load of waste/material.
- for waste received*
 - (a) origin of waste
 - (b) date received
 - (c) quantities in tonnes received and waste type as specified in Condition No: D.1
 - (d) nature of the waste (solid, liquid or sludge)
 - for waste/material removed*
 - (e) date removed
 - (f) quantities in tonnes removed and waste and/or material type
 - (g) destination of waste and/or materials removed
 - (h) nature of the waste and/or materials (solid, liquid or sludge)
- J.1.2 A summary of the information, including nil returns shall be submitted to the Agency, in a format required by the Agency. Summaries shall be for each financial year and shall be submitted to the Agency within one month of the end of each financial year.
- J.1.3 A record shall be kept of each scrapped vehicle's registration number



New Condition No. J.2

J.2 A copy of these records shall be kept at the site office for inspection during working hours by any authorised officer of the Agency.

Such modification shall take effect on 15 April 1999 at 1200 hours.
