NRW Environment Officer's Richard PALMER and Ed DAVIES completed an inspection of your site on the 8th May 2019, to assess compliance with your environmental permit. I was shown around site by Mr. Ramin Amhadi, the sites Owner/Operator and nominated technically competent person. Thank you for taking the time to discuss and demonstrate your activities on site. The site appeared well managed at the time of inspection. However, some issues were highlighted during the site inspection.

Your operation consists of a newly permitted ELV site for scrapped cars and this visit was an initial site inspection and the following points summarised below were discussed.

Technical Guidance – Operator aware of the requirements to operate within the Permit conditions and willing to comply with current and future legislative requirements.

EMS/FPMP – EMS/FPMP documents were available on site at the time of visit.

TCM – Mr Ahmadi in process of obtaining relevant WAMITAB Certification. Mr Ahmadi has successfully completed his EPOC stage of the WAMITAB and has 1 year to complete full certification. **Action: Mr Ahmadi to e-mail certificates when achieved.**

Compliance/CCS Scores, CAR Form, Public Register, Duty of Care, HWR – were all discussed through with Mr Ahmadi and NRW's position and expectations detailed and accepted by Mr Ahmadi.

The responsibility of land ownership/leasing were talked through with Mr Ahmadi by the NRW environment officer. **Action: - Full address and contact details of landowner to be e-mailed to R. Palmer. Permit and 1st CAR Form to be shown to landowner so he is fully aware of process going on at the site and is aware of his responsibilities and liabilities.**

Several cars were currently being depolluted during the time of the visit and other cars were being worked on as part of the garage aspect of the visit. All oils, lubricants and liquids were being stored indoors on a bunded pallet. Depollution was occurring only indoors in the designated depollution bay area. No Oil or waste present around the facility. Batteries were being stored in a sealed container indoors. Tyres were stacked neatly and in a good-sized pile along the site boundary.
