Environment officer Laoni Tye visited site on the 18th August 2015 with Ella Williams and Alys Rook. The weather was warm and dry at the time of the visit. Robert Davies was not on site at the time of the visit but we were advised that issues with the weighbridge were due to be resolved in October, meaning that the larger arctic lorries would be able to take waste from the site. We were pleased to see that although there were storage issues on site, some waste had been removed and the site looked well maintained. There were however a few issues and a breach that need to be addressed.

C4 – Storage, handling, labelling and segregation. Category 3 breach. Condition C8 states that 'All areas used for storage or processing at the facility shall consist of impermeable pavement.'

Whilst on site we saw that there were un-depolluted vehicles stored on hardstanding behind the weighbridge. This area is not supported by an impermeable surface with sealed drainage system and therefore oils have the potential to leak out and permeate through the ground.

Action: Please ensure waste is stored correctly on an impermeable surface with sealed drainage. You must also ensure they are fully de-polluted. Please ensure this is done no later than the 19th October 2015.

Waste returns

We have been looking at waste returns across our sites this quarter checking that they have been completed correctly and on the correct form. We have the following comments to make:

- We introduced a new waste returns spreadsheet at the beginning of the year that all sites now need to use. It now includes recovery and disposal codes and the permit number will need to be complete. Please ensure they are completed fully otherwise we will have to return them to you. The new spreadsheet is attached.
- Q2 returns are missing. Please submit these as soon as possible, using the new updated form.
- The units are not clear on the forms (K) has been used. Please ensure input and output weights are recorded in tonnages.

WAMITAB

Last time we were on site you advised that you have not managed to complete the WAMITAB qualification and you think you may be doing the wrong course. Please send me the details of the courses you have attended and the date for the next test so that we can check it is suitable.
