Officers Alex Bowder and James Perry attended on Wednesday 5th April at 10:30 to conduct a routine site inspection of J Pesci & Sons Ltd at Wernddu Works, Caerphilly, CF83 3DA - Permit number: **EPR-NP3599FC**. We were accompanied around the yard by Mr D Pesci. The weather was warm and dry at the time of visit.

Working Plan/Environment Management System (EMS)

As discussed on the inspection the site's working plan was last updated in 2005. Although operations might not have altered a great deal, it is still necessary to keep the plan up to date and in keeping with site activities and work areas. Guidance on what to include in the working plan has been sent separately.

Action: Please send through an updated version of the document to us once completed.

Good turnover of waste metal in and out of site in the last quarters. Separated metal parts stored in containers inside building.

Batteries stored on impermeable surface in containers. Spill kits present. The company Pureclean take depolluted vehicle waste liquid and parts away.

Storage of fire engines

The primary purpose of the permit is for recovery of scrap metal. It states in your permit that residual waste produced as a result of depollution has a storage time of one year prior to treatment or three years prior to recovery - please be mindful of this in regards to the fire engines around the yard and remove waste that has been stored for more than the permit allows.

No issues with drainage systems or interceptors at the time of visit.
