Appendix C data

Appendix C data for 2014 was reviewed and some errors were found. There was duplication of figures for April and June. When reviewing the procedures for calculating the tonnages to input in to the Appendix C's, some of the data in your spreadsheet was different to that submitted to us last year. Your procedures for calculating the tonnages, however, appears sufficient and the errors have been attributed to administrative error this time.

Action: review 2014 Appendix C data, with particular attention to April and June, and resubmit the correct Appendix C's by the 30th April 2015. Ensure that future appendix C data matches your records.

Mass balance figures were taken as part of an AATF audit, and a separate report for the AATF audit will be provided.

Site inspection

A site inspection was undertaken following the audit of figures. The large gas cylinders have been moved towards the back of the unit to make room for a new conveyor belt system towards the front of the unit to aid loading of fridges in to the stage 1 degassing plant.

Compressor pots were being checked whilst conducting the site inspection. Staff were tipping up the compressors over an IBC to check any oil residues were remaining. Any compressor found with oil was left tipped on the grate to drain into the IBC, they were then being checked until traces of oil were not visible from the cut pipe.

The baler was operational and being used to bale LDA following removal of components. Televisions which were not suitable for reuse were being bulked up around the side of the main unit, waiting for a full load so they could be removed from site. These were wrapped and on pallets.

There was no evidence during the site inspection that stage 2 operations have been conducted, in line with the advice given during the last inspection.
