This was a routine Site Inspection carried out by Environment Officer's Alys Jones & Alastair Wilson. The Inspection was not pre-arranged. The purpose of the visit was to inspect all aspects of the Environmental Permit, however upon arrival officers were informed that Mr Williams was unavailable due to unforeseen circumstances.

Officers proceeded with a visual inspection of the site; they were accompanied by a site operator. The Site Operator explains that he cannot show them any paperwork today i.e. Permit, EMS & Diary

On the previous inspection Officers were concerned that the site was accepting waste material not specified in their Environmental Permit i.e. a WEEE waste items. On this visit Officers, did not witness WEEE items.

Officer advises that the site could do with some general housekeeping and expresses concerns that the site is being left unmanaged whilst Mr Williams is away. Officer asks how often the Technical Competent Manager has been visiting however the site operator is unsure.
