First inspection of new regulatory officer Kelly Sherratt to site Thursday 18th May 2017

Un announced visit with Officer Nessa Dearle. Time on site 12.10- 13.45 Hrs. Introductory visit, Mr Andrew Green showed both officers around the site, and ran through the operating procedures on site.

Main Points raised from the visit full skips of mix general waste stored on the top of the hardcore platform, which has just been specified for the storage of inert material.

Cat 3 breach recorded against permit condition 2.3 Operating techniques. This permit conditions states "Unless stored or treated outside as a specified waste.

a) all bulking, transferring or treatment of waste shall be carried out inside a building

b) all waste shall be stored in a a building or within a secure container.

c) all waste shall be stored and treated on an imperable surface with sealed drainage system."

All full mixed waste skips awaiting sorting, need to be stored in the above manner. Only inert material can be stored on hardstand.

Also your EMS refers to your WTS building having doors to prevent airbourne emissions, on this visit the waste being stored within the building was significant and spilling outside of the boundary of the building. This volume needs to addressed, and fire breaks within the waste mass are advised. No doors noted, but could be hidden behind waste mass.

Requested via email detail on site TCM, and certificates to be sent in.

I will write to the site separately to discuss the use of U1 exemption to use as gabion baskets, as this is not related to your permit, but to do with the planning permission for site. ref 12/0500/10 RCTCBC
