This was a routine unannounced site inspection by Natural Resources Wales (NRW) officers Alastair Wilson (Environment Officer), and Heidi Markham (Environment Officer).

Throughout the inspection weather conditions were cold with light drizzle.

Upon arrival the officers introduced themselves at the site office. The site Technically Competent Managers were not present, but a waste manager was able to show us around the site. The waste manager was reminded that the TCM, Haydn Williams' technical competency qualification would expire on 28/1/2018, he told us that he had already booked in for a refresher assessment.

Unfortunately it was not possible to inspect the site diary, licence, working plan or waste transfer notes as staff did not know where they were stored. This was also recorded as a compliance breach in the Compliance Assessment Report issued to the site on 02/11/2015. You need to make sure that there is a suitably trained person available on site when the site is open.

### **CAR sub criteria C1, Permit condition 1.3.1, Compliance Classification Scheme Category 3 breach.**

*As specified within condition 1.3.1 of the site permit "Whenever the site is open to receive of despatch waste, or is carrying out any of the specified waste management treatment or disposal operations, it shall be supervised by at least one member of staff who is suitably trained and fully conversant with the requirements of the licence and the working plan..." A category 3 non-compliance has been recorded.*

The site was clean and tidy, with good waste segregation and signage, impermeable surfaces were in good condition as were storage containers. There was a significant quantity of waste fridges and freezers, and other bulky white electrical goods (WEEE).
