Compliance Assessment has been undertaken in relation to permit condition 4.2.2. Your permit requires waste returns to be submitted quarterly.

All returns for 2016 and 2017 have been submitted in accordance with permit conditions.

A total of 1,897.5 tonnes has been received since the site started to accept waste in quarter 4 of 2016. No waste has been removed since the site started accepting waste. A site inspection will be made in the new year to assess the waste stored on site and discuss treatment and removal of waste.

According to your waste returns, the following non-permitted waste types have been accepted onto site:

17 04 05 - iron and steel

17 09 04 - mixed construction and demolition wastes other than those mentioned in 17 09 01, 17 09 02, and 17 09 03

These wastes are not listed under Schedule 2 of your permit (Table S2.1) and therefore must not be accepted on to site. In addition, the descriptions given with the codes do not match the waste catalogue descriptions. No breach has been given at this time for this non-compliance, but if non-permitted waste types are accepted in the future then you may be breached for non-compliance with your permit.

***Action*** - review the waste returns and provide reasoning for the above wastes being accepted on to site by **31st January 2018**. Procedures need to be reviewed to ensure that non-permitted waste types are not accepted onto site again.
