3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

This was an unannounced site inspection undertaken by Hazardous Waste Regulation Officer, Kathryn Bradshaw. I was met on site by Joe Williams, site manager who requested I sign in and accompanied me around the site.

The site operates a booking in system and the site had a steady flow of bookings whilst I was on site.

I was told the site had a busy weekend and some areas of the site were looking untidy with some litter to the rear of the yard. The rest of the yard was tidy with all waste types clearly signed.

The storage containers for the batteries, lightbulbs and fluorescent tubes were all full. These require emptying as soon as possible. The furniture section of the site was full, awaiting stripping down and the resultant wastes being placed in the different skips. This was of concern as the furniture was all being stored next to the batteries. These wastes need to be segregated to minimise the fire risk on site.

The small mixed WEEE area was untidy with some items stored on a table and more stored in a wheelie bin. These items were waiting for the cables to be removed before placing in the large Ro Ro skip.

A copy of the permit was kept in the office and I also viewed some waste transfer notes, all were in order. The TCM was last on site on 16/03/2022.

Non compliance from site visit:

Permit condition 1.1.1 - the activities shall be managed and operated:

(a) in accordance with a management system, which identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents and non-conformances and those drawn to the attention of the licence holder as a result of complaints.

All the actions detailed below are a result of poor site management, wastes left to accumulate, poor containment of wastes and potential fire risks.

Actions from site visit:

- Remove the full containers of batteries, fluorescent tubes and lightbulbs immediately
- Segregate the waste furniture from ignition sources on site (including batteries) immediately
- Process the waste furniture to reduce the amount being stored
- Process the small WEEE waste to reduce the piles being kept outside the large skip
