3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A routine site inspection was undertaken on Friday 18th March 2022.

During the inspection the following observations were made:

Waste Storage

Natural Resources Wales officer, David Morgan, arrived on site just as the site was opening for the public (11:00).

All wastes were clearly labelled, segregated and stored safely. All wastes on site appeared to conform with the list of acceptable wastes in the Environmental Permit for the site.

In the oil storage area, there was evidence of a spillage, but pollution prevention measures had been implemented. It is good practice to remove these granules/pads etc. at the nearest convenience.

Site Boundary

An inspection of the site boundary was undertaken. The site fencing appeared to be secure and well maintained, but does not prevent waste and litter from escaping site. On the site boundary fencing, bordering the school property, there was a build up up litter including plastic packaging, polystyrene.



When asked, staff on site said they were prohibited from clearing this waste/litter because it would require them to leave site. This issue should be addressed. Please remove waste, litter and other debris from the site boundary. Measures should be taken to routinely address this issue (daily checks) and prevent it from reoccurring through the installation of netting etc.

A non-compliance was recorded against condition 2.1.1 of the Environmental Permit (Category 3 - Minor) (Ref:F3)

Environmental Permit & Fire Prevention and Mitigation Plan

Following an inspection of the operational areas of the site, a discussion was held with site operatives.

At the time of the inspection, site operatives did not have convenient access to a copy of the Environmental Permit, Environment Management System and Fire Prevention and Mitigation Plan.

A non-compliance was recorded against condition 1.1.3 of the Environmental Permit (Category 3 - Minor) (Ref:C2)

You must ensure site operatives have access to a copy of the Environmental Permit conditions.

RECOMMENDATION: It is recommended that in-house training is offered to site operatives so they can be made aware of the Environmental Permit and their role in helping to achieve compliance with the permit conditions. It would also be advisable to offer training/raise awareness of the Environment Management System and Fire Prevention and Mitigation Plan.

I have requested that these non-compliances be rectified by Friday 1st July 2022.
