This was a routine, unannounced, site inspection. Officers were accompanied by the Environment, Health and Safety Compliance Manager.

Gas engine 1 was running. Gas engine 2 was not operational and was being assessed by engineers at the time of the inspection. From discussion with the engineers, it is likely that engine 2 will need to be repaired.
